General Information & Policies

GUARANTIES

The guaranteed number of attendees must be specified and communicated in writing by 11:00am, 14 business days prior to the event. This number will be considered the final number of attendees and is not subject to reduction. If no guarantee is received, the expected number of attendees listed on the contract will be considered your guarantee. If the actual number in attendance surpasses the guarantee, the client will be billed for the actual amount in attendance. If the total wedding minimum is not met, the remaining balance will be applied as a venue fee.

DEPOSITS & PAYMENT

Payments may be provided in the form of cashier's check or credit card. All events must have a credit card on file with a signed credit card authorization form. The balance of the event will be charged to the credit card on file if no other arrangements are made.

The following payment schedule will apply:

- A non-refundable deposit of \$2500 is due upon signing of the contract in order to reserve the event space and date.
- 90 days prior to the event date 50% of the total event estimate is due
- 45 days prior to the event date 75% of the total event estimate is due
- 14 days prior to the event date final counts and the remaining balance is due

Event is based on a 6 hour period beginning at the ceremony start time. Additional half hours may be purchased at \$250 per half hour and additional hours may be purchased at \$500 per hour (not exceeding 11:00pm).

SERVICE CHARGE & SALES TAX

A 22% taxable service charge will be added to all food and beverage. All federal and local taxes which may be imposed or be applicable to the contract and the services rendered by Blackstone Country Club are in addition to all prices herein agreed upon.

CANCELLATIONS

Deposits are non-refundable. The following cancellation schedule for food, beverage and room rental will apply for all events:

- 91+ days prior to the event: loss of \$2500 non-refundable deposit
- 90-46 days prior to the event: loss of 50% of the total
- 45-15 days prior to the event: loss of 75% of the total
- 14 days or less prior to the event: loss of 100% of the total

DECORATIONS

The client is responsible for set-up and removal of all items. All decorations must meet with the approval of the Peoria Fire Department, i.e. smoke machine, candles, etc. Blackstone Country Club will not permit the affixing of any items to the walls or ceiling of rooms unless written approval is given by the Events Manager. ***Please note sparklers are not permitted on property; all other grand exits/entrances must be approved by the Events Manager.**

FOOD & BEVERAGE

Blackstone Country Club will provide all food and beverage served within Blackstone Country Club property, including the locker room suites. It is our policy not to permit food and beverages to be brought onto or removed from Blackstone Country Club grounds. All outside food and beverages will be confiscated. Candy guest favors and/or a "candy table" are permitted. Maricopa County and the State of Arizona health regulations prevent the Club from providing extra food and beverage for guests to take home. Consuming raw or undercooked meats, seafood, poultry, shellfish or eggs may increase your risk of food borne illnesses.

ALCOHOLIC BEVERAGES

The sale and service of alcoholic beverages is regulated by the Arizona State Liquor Commission. Blackstone Country Club, as licensee, is responsible for the administration of these regulations. It is our policy that no type of alcoholic beverage be brought on to or removed from the property of Blackstone Country Club. In accordance with the Arizona State Liquor Commission, the Club cannot sell or deliver to a person an unlimited number of spirituous liquor beverages during any set period of time for a fixed price. The Club reserves the right to (1) request proper identification (photo ID) of any person of questionable age and refuse alcoholic beverage service if the person is either under age or proper identification cannot be produced and (2) refuse alcoholic beverage service to any person who, in the properties' judgment, appears intoxicated. **Items on our menu and their prices are subject to change two weeks out from the event date due to market conditions.**

MENU TASTING

Complimentary tasting for the bride and groom may be arranged through the Events Manager. Choice of two salads, two entrees and four cake and four mousse combinations will be provided. Additional attendees (up to 4) can be accommodated; additional plates may be purchased at 50% menu price. Tastings are offered Tuesday-Friday and select Saturday's beginning at 11:00am and no later than 4:00pm. Tastings must be scheduled and choices selected no later than 7 days prior.

DAMAGES

Blackstone Country Club is not responsible for the loss or damage of any personal or contracted items on property before, after or during the event. The client is responsible for any damages incurred to Blackstone Country Club property or any contracted materials. The host acknowledges and accepts any and all risk of injury to all attendees and their respective properties that may be sustained while on Blackstone Country Club property.

A \$500 damage deposit is due upon signing of the contract. The deposit is fully refundable if no damages are incurred. Any damage to the bridal suite, groom's suite or property will result in loss or deduction of the deposit. Other damage deposits may be required.

STORAGE

Boxes and items may be brought to Blackstone Country Club a maximum of one day prior to the scheduled event. Pick up of all items must be arranged for the evening of the event by the conclusion of your event or by 11:00pm, whichever comes first. Items not picked up by scheduled timeframe will be discarded. All contracted items must be removed by the conclusion of your event or by 11:00pm, whichever comes first. Blackstone Country Club is not responsible for the damage or loss of any merchandise or personal articles before, after or during the event.

OUTDOOR EVENTS

Interior space is not available at Blackstone County Club. In case of inclement weather, all decisions for tenting will be made at least 72 hours prior to the scheduled event time. Cancellation fees will apply if the tent is cancelled within 72 hours of the event. The client is responsible for all tenting costs. Blackstone Country Club assumes no responsibility due to the effects of inclement weather. If no action is taken, the client assumes the risk of inclement weather and any ramifications thereof. If an event has been booked during the months of December through February or June through August, Blackstone Country Club reserves the right to require that a tent with proper heating or cooling units be rented for the ceremony and/or reception. Due to local noise ordinances, all outdoor entertainment must cease by 11:00pm.

LOCKER ROOM SUITES

A \$300 Locker Room Attendant fee will be billed to the client for one female and one male attendant for 8 hours each. Wedding parties may use Blackstone Country Club's locker room suites up to 3 hours prior to the scheduled event time and will have access to the suites until the conclusion of the event. Wedding party and



immediate family only are allowed into the locker room area. Wedding parties are responsible for the delivery and removal of their items to and from the locker room suites before and after the event. Blackstone Country Club is not responsible for any personal items left or damaged in the locker rooms. Wedding parties are responsible for the disposal of all trash into receptacles, straightening of lounge areas, etc. Unless arrangements have been made prior to the event, use of showers, steam rooms, robes and slippers is prohibited. No music, other than what is provided by Blackstone Country Club, is allowed to be broadcast in the locker room. Mobile phones are prohibited in the locker rooms, except in lounges and on patios. Smoking is permitted outside on the locker room patios only.

No photographers, hair stylists, make-up artists, etc. of the opposite gender allowed into the locker room unless previously authorized and approved by the Event Manager.

ATTIRE

Proper attire must be worn at all times while on Blackstone Country Club property: (1) shoes must be worn at all times in the locker room foyers, courtyard, Cantina Bar, and all dining areas, (2) men must wear collared or mock-collared shirts at all times, (3) no sleeveless shirts for men, (4) no torn or excessively worn jeans for men or ladies, (5) no undergarments showing, (6) hat brims must be facing forward, (7) no beachwear/swimwear permitted.




